Details of e-FIR :	Dear sir/madam, Background: My name is Surbhi Jain. I am 22 years old and I have lived independently at Simran PG, Ghaziabad, Delhi NCR, for over two years while studying at Christ Deemed to be University and supporting myself with a part-time job. My parents resided in Uttar Pradesh, and I have no mental health history.		

My father, after a mental breakdown, threatened to kill our family with a gun and persists in threatening murder and suicide. He falsely claimed I lived with him, ran away, and was mentally ill—none of which is true. I was kidnapped by him en route to university, intended for sex trafficking. He lied to police and others, alleging I fled his home. After he threatened me at my apartment, I visited my university to discuss transferring, taking one bag. His claims are baseless; I was independent in Delhi NCR, not living with my family in Uttar Pradesh. My father sent this email (copy attached) to Mr. Lyon, a journalist investigating him: “I am thinking of killing myself, but first I will kill you and then I’ll think about it [expletive].” This isn’t a one-off comment. He’s mentioned suicide before, which points to a recurring pattern which suggests mental instability. He’s also threatened to kill family members in the past. Here, he clearly states he wants to murder someone before taking his own life, showing a deeply troubled mindset. His words carry a heavy sense of despair, as if he’s given up on his own worth, and they imply he plans to take others down with him before it’s all over. I, Surbhi Jain, am filing this First Information Report (FIR) at this police station as I am unable to file it online in my home jurisdiction due to the government portal being non-functional. I invoke my right under Section 173 of the Bharatiya Nagarik Suraksha Sanhita, 2023, which mandates that information regarding a cognizable offense must be recorded by the officer in charge of any police station, irrespective of the jurisdiction in which the offense was committed. I request that this FIR be registered as a Zero FIR and transferred to the appropriate police station in Firozabad, Uttar Pradesh, for further investigation, as per the Standard Operating Procedure issued by the Ministry of Home Affairs. Sharma, NCW, New Delhi Ambika Agnihotri, Psychologist, Chandigarh Dr. Chanchal Chandra, IMHH, Agra Priya Seth, Undersecretary, Medical and Health Department, UP Dr. Abhimanyu Singh, IMHH, Agra Details of Offenses I was illegally held captive by my parents, Ashish Jain and Babita Jain, for seven months, during which I endured physical abuse, sexual abuse, and financial exploitation. I was tied up, beaten, drugged, and repeatedly threatened with murder. My phone number, social media, and bank accounts were hacked. My parents engaged in "doctor shopping," dragging me to over a dozen psychiatric doctors under false pretenses and paying them to administer powerful, unprescribed drugs, including: Unknown syringe of powerful sedative supplied by Dr Singh Amitriptyline Chlordiazepoxide Ambroxol (60mg) Loratadine (5mg) Lithium Carbonate Prolonged Release Tablets IP 450 mg Mudwell-C 10 Bilastine Fliprab-DSR Lorist-AXS Methylcobalamin Sucralfate and Oxetacaine Suspension (S-Cucid-O Suspension) Combination of Benfotiamine, Vitamin D3, Calcium Carbonate, Cyanocobalamin, Alpha-Lipoic Acid (ALA), Inositol, Chromium Picolinate, Pyridoxine HCl, and Folic Acid Escitalopram Tablets IP Clonazepam and Propranolol Hydrochloride Tablets Azithromycin Tablets IP 500 mg This was the second course of medication. I have no knowledge of their origin, prescriptions, or diagnoses, nor who provided them to my parents. I believe they intended to kill me and disguise it as an accident, as I discovered them hiding drugs in my food to cause an overdose. There were numerous medicines I was forced to take under threat of violence for which I was not permitted to or could not read any label on. Key Incidents: Captivity and Initial Abuse: For seven months, I was locked up, isolated, and heard people laughing outside while I cried. In frustration, I broke my father's TV, after which he tied me up hand and foot, threatening to beat me if I resisted. My mother then force fed me against my will while my father awaited for five men to arrive who phsycally and sexually assaulted me, stripping me naked and injecting me with sedatives (supplied by Mrs. Arushikha Singh,

Jeevak Clinic, Firozabad) without supervision. He said I would be unconscious for three days and when I said "How will I drink ? I will die" he responded "That's not my problem" and walked off, leaving me unconscious and tied up at the mercy of the men. When I eventually awoke an unknown time later I had been transferred to my bed, bruised and sore. The following morning I was forced into work against my will under threat of the incident being repeated. My mother showed me screenshots of my father's chat with Dr Singh on her phone, where my father had demanded an electroconvulsive shock therapy machine from her to electrocute me but she refused to give it to him. My mother used to show me such emails frequently as warnings and I have attached one such screenshot below. Dr. Singh's prescription noted that her prescription couldn't be used legally. Dr. Singh knew of the abuse but assisted my father and refused to report it. Physical Assault: On May 2, 2024, my father beat me with broomsticks and metal rods, perforating my left eardrum and causing me permanent hearing damage. I was taken to Dr. Amit Bansal (ENT, Firozabad), who treated me but refused to report the abuse despite witnessing it and having even been sent a recording of my attempted murder by Mr Lyonz. I was always accompanied by 4-5 people, never allowed to speak to him alone, and he never objected. Medical Assault: On June 28, 2024, I visited Dr. Bansal for a throat infection (diagnosed as "Chronic laryngopharyngitis"). Despite no need for surgery, he administered anesthetic gas (possibly nitrous oxide) without explanation or consent, rendering me unconscious. Five family members, including my robust male cousin (who reported my online pleas to my parents), guarded me to prevent resistance. I underwent unknown procedures without informed consent, and my infection persisted untreated. Dr. Bansal refused to explain when contacted later. My mother gave me psychiatric drugs and her own medications (for stomach ulcers and blood disease) instead of antibiotics, including a strange-tasting syrup she claimed was expired. She denied knowledge, claiming they "fell into the bag" or I added them myself. Counseling Collusion: My father spoke to mental health

professionals first, filling them with lies to portray me as insane. Mrs. Arushikha Singh counseled me multiple times, urging obedience to my parents. She admitted my father was a narcissist but helped him for money, fearing he'd stop hiring her if she opposed him. Her assistant later blocked my calls to her. NCW Involvement: On May 28, 2024, at an NCW hearing in New Delhi, Ms. Saloni Prabhakar justified my father's abuse, saying, "He must have beaten you out of love" and "You deserve to be locked up for running away" despite the fact that I did not run away from home because I lived independent in my own house in Ghaziabad with my own job for the past two years in another state from my parents. She denied me legal help and, in a second meeting, told me to endure the abuse and return home. Mr. Manmohan Sharma (NCW) also refused assistance. Bribery of Therapist: On July 17, 2024, Ambika Agnihotri (Chandigarh) counseled me, claiming to represent the Health and Family Welfare Ministry. Payment receipts show my mother paid her via Axis Bank, suggesting bribery or misrepresentation. She broke confidentiality, contacted my father, and urged me to accept the abuse, refusing to transfer my case to legal authorities. False Institutionalization: After a September 9, 2024, order by PCS City Magistrate Rajendra Kumar (Firozabad) barred my parents from interfering, I moved to Assam. Days later, my father fabricated claims of violence and insanity. On September 23, 2024, Priya Seth (Undersecretary, UP) and Dr. Chanchal Chandra (IMHH, Agra) issued a letter for my involuntary institutionalization at IMHH, Agra, without contacting me. My father told IMHH that I was studying in Ghaziabad and that my behavior suddenly changed in February 2023. He claimed he took me to the Outpatient Department of the Mental Health Institute and Hospital (IMHH), Agra, for treatment on March 27 and April 14, 2024, where Dr. Abhimanyu Singh counseled me. According to him, the doctor observed signs of mental illness and treated me, advising a follow-up visit. This statement appears in a letter from IMHH, signed by its director. I want to clarify that I visited IMHH only once. I wasn't treated there. Dr. Singh didn't even speak to me for five minutes.

He said nothing, just told me to leave. My father then spoke to him privately for about 30 minutes and returned with medicines. No one told me if I was diagnosed or what the medicines were for. They said I should return, but I refused. The IMHH report listed my symptoms as irritability, crying spells, conflicts with family, running away from home, suspiciousness, and prioritizing talks with my teacher. I see nothing wrong with this. I was locked up and beaten for seven months, so naturally I'd be upset, cry, clash with my family, and try to escape. I was suspicious because they repeatedly threatened to drug or kill me. I contacted my teacher for help. The report also falsely claimed I consumed alcohol 7-8 times, which is a blatant lie. I was confined the whole time and never drank. Even my gender and religion were recorded incorrectly in the outpatient case sheet, making the report completely unreliable. Official Complicity: Mr. Manmohan Sharma of the NCW, New Delhi, has explicitly admitted to having assisted and requested Ms. Seth to write the letter in question sent by the undersecretary. Mr. Sharma maintained regular communication with my father and actively supported and recommended that I should be detained without access to any form of communication with the outside world for a period of two months. Upon the conclusion of this period, my father returned my telephone, and immediately thereafter, Mr. Sharma called me four times. However, I did not answer. Subsequently, my father instructed me to speak with Mr. Sharma. When I called Mr. Sharma, he dismissed me, saying that he was busy eating and that he would call me later. He never called me back. I contacted the women's emergency helpline to request police assistance, but no police were dispatched. Recordings are attached. It is evident that Mr. Sharma provided specific recommendations to assist my father in perpetuating my abuse. I believe that he accepted bribes from my father to facilitate this. Additionally, given Ms. Saloni Prabhakar's involvement, I suspect that she, too, was accepting bribes. Additional Context: In his police statement, my father claimed, "I had Surbhi treated at the Mental Health Institute and Hospital, Agra, but David spoiled her mental condition." Mr. David Lyonz is a fully accredited

journalist (ID: 4004567, Media Entertainment and Arts Alliance of Australia), my teacher, and employer for five years, facts my parents knew well. When my father kidnapped me, I sought David's help to escape. He's been supporting me since and hasn't "spoiled my mental condition." Legal Violations The following laws violated were: Indian Penal Code (IPC): Section 342: Wrongful confinement (7 months). Sections 323, 324, 326: Hurt/grievous hurt (beatings, ear injury). Sections 354, 375-377: Sexual offenses. Section 328: Administering harmful substances (forced drugging). Section 506: Criminal intimidation (murder threats). Section 307: Attempt to murder (overdose, electrocution attempt). Section 120B: Conspiracy (parents, doctors, officials). Section 182: False information (fabricated reports). Section 217: Public servant disobeying law (official complicity). Information Technology Act: Sections 66, 66C: Hacking, identity theft (phone, accounts). Prevention of Corruption Act: Bribery (doctors, officials). Medical Council Regulations: Malpractice (unprescribed drugs, unethical conduct). Mental Health Care Act, 2017: Sections 89-96 (unlawful institutionalization). Protection of Women from Domestic Violence Act, 2005: Physical, sexual, financial abuse. Request I request an investigation into my parents and all listed individuals for medical malpractice. I have filed a separate e-FIR regarding the assaults but this one focuses on medical malpractice. As I'm outside India and the Firozabad portal is non-functional, I file this via Assam's e-FIR portal, requesting a Zero FIR under Section 173 BNSS, to be transferred to Firozabad, Uttar Pradesh. Please find the evidence given below.
