Details of e-FIR :	Respected Sir/Madam, My name is Surbhi Jain. I am a 22-year-old woman. I am filing this First Information Report (FIR) to report a series of cognizable offenses committed against me by my father, Ashish Jain, and others. The offenses		

took place at Flat No. 802, Platina Heights, Firozabad, Uttar Pradesh 283203, from 10 February 2024 onwards. I was unable to file an FIR in Firozabad because the online portal in that jurisdiction was non-functional, and the Line Par Firozabad Police Station officials refused to register my complaints despite multiple attempts. Hence, I am filing this Zero FIR here, invoking my right under Section 173 of the Bharatiya Nagarik Suraksha Sanhita, 2023, which mandates that information regarding a cognizable offense must be recorded by the officer-in-charge of any police station, irrespective of the jurisdiction in which the offense was committed. I request that this FIR be registered as a Zero FIR and transferred to the appropriate police station in Firozabad, Uttar Pradesh, for further investigation, as per the Standard Operating Procedure issued by the Ministry of Home Affairs. Details of the Incident: Kidnapping and Illegal Confinement: On 10 February 2024, I was kidnapped by my father, Ashish Jain, and illegally held captive for seven months in his residence at Flat No. 802, Platina Heights, Firozabad, UP 283203. I was restrained against my will, tied up hand and foot, and prevented from leaving. Physical Abuse: During this period, I was violently beaten with sticks and rods, resulting in serious injuries, including permanent hearing loss. I was hospitalized for treatment, and my medical reports are attached as evidence. Sexual Abuse: I was sexually assaulted by five men while tied up and knocked unconscious during the assault. This occurred under the supervision or facilitation of my father. Financial Abuse: My father subjected me to financial exploitation, depriving me of my resources through coercion and threats. Threats to Life: I was repeatedly threatened with murder by my father. I have attached a video recording showing him attempting to murder me as evidence. Police Inaction: Despite presenting this evidence to officials at Line Par Firozabad Police Station and submitting written complaints (attached), no FIR was registered, and I was not provided copies of my complaints. No government official has acted on my case, despite listening to the recording. Legal Provisions Violated: The following laws under the Bharatiya Nyaya Sanhita, 2023 (BNS)

(which replaced the IPC) and other statutes have been breached: Section 140(1), BNS (formerly Section 363, IPC): Kidnapping. Section 127, BNS (formerly Section 340, IPC): Wrongful confinement. Section 117(2), BNS (formerly Section 325, IPC): Voluntarily causing grievous hurt. Section 117(3), BNS (formerly Section 326, IPC): Voluntarily causing grievous hurt with dangerous weapons (sticks and rods). Section 351(1), BNS (formerly Section 503, IPC): Criminal intimidation. Section 351(2), BNS (formerly Section 506, IPC): Criminal intimidation with threats to kill. Protection of Women from Domestic Violence Act, 2005: Physical, sexual, emotional, and economic abuse by my father, a family member, violates this Act. Police Inaction: The refusal by Line Par Firozabad Police Station officials to register my FIR violates Section 173 of the Bharatiya Nagarik Suraksha Sanhita, 2023, which mandates the recording of cognizable offenses. Their failure to provide me with copies of my complaints further obstructs justice. Request: I urge you to: Register this as a Zero FIR under Section 173 of the Bharatiya Nagarik Suraksha Sanhita, 2023. Transfer it to the appropriate police station in Firozabad, Uttar Pradesh, for investigation. Take immediate action against the perpetrators, including my father, Ashish Jain, and the five unidentified men. Investigate the inaction of Line Par Firozabad Police Station officials.
