1. On 2nd May 2024, my father beat me with broomsticks and metal rods, damaging my left eardrum and causing temporary hearing loss. I was taken to Dr. Amit Bansal (ENT Specialist) in Firozabad for treatment. Despite witnessing the crime, Dr. Bansal refused to help me report my father. During multiple visits for my ear injury, I was always accompanied by 4-5 people and never allowed to speak to him alone, which he never objected to.

On 28th June, I visited Dr. Bansal again for a throat infection and was diagnosed with "Chronic laryngopharyngitis." My mother picked up the medicines from the pharmacy outside Dr. Bansal's clinic, but I was not given any medication for the infection. Instead, my mother gave me psychiatric medicines and her own medications for stomach ulcers and blood disease. I was never given proper antibiotics, except for a single unknown tablet from a used blister pack.

When confronted, my mother denied knowledge of the psychiatric medicines or her own medications being forced on me, claiming they must have accidentally "fallen into the bag" or that I had put them there myself. This is a serious crime, as my mother knowingly drugged me to sedate and keep me sick. Dr. Bansal's refusal to report the abuse or speak to me directly without interference suggests he is unlawfully assisting my parents in my forced and unprescribed drugging, fully aware of their past abuse.

2. Between the 8th and 10th February, the day my father smashed my macbook, I went to our old neighbor's place with her as I was scared. In the evening, my parents came to the place and they manipulated the neighbor and my parents started leaving in the car. I said I do not want to go in the car. However, my father insisted that my professor is calling so I need to talk. I said give me the phone but he didn't and said it's a google meet, please sit inside and check for yourself. The neighbor also started saying that I "shouldn't do drama

on her street”. I was pressured so I sat in it. There was no professor, instead they made me talk to a psychologist. The car was stuffed with me, my mother, the father, the neighbor and Driver Rishipal. I was sitting in between. I said to the psychologist that “There are so many people around and it’s very uncomfortable for me to talk. As you are a psychologist, you must know that this is very unethical.” He and the neighbor started insisting that I should at least tell him my name and where I studied and all. The neighbor was saying that I “shouldn’t teach the professional himself”. I asked her to not interrupt me but I did tell the psychologist my basic details like my name and where I studied. When we reached Platina Heights Apartments, they all came out of the car and gave me space to talk to him in the car. I told him about the kidnapping and what my father has done. He didn’t say anything much but asked me to come to his clinic. I didn’t ask for his name or any details.

3. One day my father said that he is going to his doctor and he will take me and my mother. I said i do not want to go but he was insistent that he can’t leave me alone. I went with him to Agra and I found out that he lied to me and he actually wanted to take me to the psychologist. I went to his clinic, went inside, told him about my parents and what they are doing. I also told him about bed wetting and if I have ADHD. He said that it doesn’t seem like I have ADHD as I was not restless talking to him. However, he said I should go for a psychological report which will prove that I am mentally okay and can make my own decisions. He said that it’s not his case and that we should go to Mental Hospital in Agra for counseling. Few days later, my father asked me to go for counseling but I did not go as he lied to me earlier. He went by himself and said that he has got his counseling done and it feels nice and I should also go.

4. Sometime before 11th March, Dr. Arushikha Singh from Jeevak Clinic came to the house and she talked to my parents on the dining table for like an hour. Then she came to me and said to her that I don't want to talk to her. She was like "that's how you talk to people?" and then she came in. I was just painting mandalas the whole time I was talking to her. I told her everything. Then she came to the house 2-3 times more and then started calling me and my mother to her clinic. She said she is doing family therapy so she used to talk to me and my mother both separately. She was planning to counsel my father as well. She did not diagnose me with anything and did not say that there is anything wrong with me. She did not make me do any tests. She used to force her opinions on me and was trying to make me what she and my parents want. She wanted me to comply and said if I comply I will get my freedom slowly. She also gave me some medicines which she said were mood stabilizers. I heard her call recording talking to my father where my father was saying that I scream and cry a lot and she said that I have an internet addiction and I should be kept away from electronic gadgets as much as possible. She said if I would be kept away from gadgets for long enough, then I will get used to not having them. However she never informed me about any such addiction and it felt like she was planning with my father in executing whatever he wanted to. One day I broke the TV in frustration and my father tied me up. And he already had an injection which Dr. Arushika gave him. Even after me asking him to not give that to me. He and his staff members held me on the sofa and forcefully gave the injection to me. He said I would be unconscious for 3 days but I regained consciousness in 2 hours. My mother showed me the screenshot that my father sent her that Dr. Arushikha asked him to give me the injection. My father also demanded her for an electroconvulsive therapy machine to electrocute me and I have a whatsapp chat record of the conversation. After that I never talked to her again. When I went to NCW, Dr. Saloni, who is a psychologist, said that there was a note in Dr. Arushikha's prescription that it can't be used for legal purposes. She would ask me to obey my parents but at one point she admitted that she believes that my father is a narcissist but she is only doing it and helping him for money. She said if she spoke against him, he would not hire her further. I tried to contact her several times later but I was always refused by her assistant.

After some time, my parents took me to temples in other states. And on the way in a restaurant which was built inside the Mangalayatan temple, I started crying and said that I want to leave. My father said if the psychiatrist would say that you are okay then I will let you leave. So the next day we went to Mental Hospital in Agra. There was a huge rush and we had to wait for a while to meet the counselor but they said that I will go to a psychiatrist and there I can tell everything. I went to the psychiatrist. There was one male and one female doctor or intern. The male doctor Dr. Abhimanyu Singh was very disinterested to listen and he was not even speaking and was gesturing to the lady to ask me questions. I talked to them for barely 5 minutes and told them about what my parents are doing. He asked me to leave as he said that "it is enough". I left and my father went inside and talked to them for some time. He came out with some medicines and said that the doctor has said that I have deep depression and I need to come visit them again after 10 days. I took medicines for a short period of time but didn't complete the course. David checked the medicines and they seemed like they were bipolar medicines. I didn't go there again. But my father claimed he took me to the Outpatient Department of the Mental Health Institute and Hospital (IMHH), Agra, for treatment on March 27 and April 14, 2024, where Dr. Abhimanyu Singh counseled me. According to him, the doctor observed signs of mental illness and treated me, advising a follow-up visit. This statement appears in a letter from IMHH, signed by its director. I want to clarify that I visited IMHH only once. I wasn't treated there. Dr. Singh didn't even speak to me for five minutes. He said nothing, just told me to leave. My father then spoke to him privately for about 30 minutes and returned with medicines. No one told me if I was diagnosed or what the medicines were for. They said I should return, but I refused. The IMHH report listed my symptoms as irritability, crying spells, conflicts with family, running away from home, suspiciousness, and prioritizing talks with my teacher. I see nothing wrong with this. I was locked up and beaten for seven months, so naturally I'd be upset, cry, clash with my family, and try to escape. I was suspicious because they repeatedly threatened to drug or kill me. I contacted my teacher for help. The report also falsely claimed I consumed alcohol 7-8 times, which is a blatant lie. I was confined the whole time and never drank. Even my gender and religion were recorded incorrectly in the outpatient case sheet, making the report completely unreliable.

6. On 29th April, I heard my mother talking to some lady who appeared to be a mental health professional and she was completely lying to her that David didn't want to talk to my father ever etc. She wanted me to talk to the lady but I refused to talk.

On 28th May 2024, I attended the hearing of my case at the National Commission for Women (NCW) New Delhi, where I first met Ms. Saloni Prabhakar, a psychological counselor. She openly supported my abuser's crimes, making statements like "He must have beaten you out of love" and "You tried to run away from him (my abuser), so you deserve to be locked up." In a second meeting, she continued to justify my father's crimes, suggesting I needed to change my mindset, endure the abuse, and return to my parents' place. I submitted a detailed statement to NCW explaining the events and requesting legal help, but I was denied the legal help and the two people who are responsible for that are Ms. Saloni Prabhakar and Mr. Manmohan Sharma from NCW.

8. There was another lady psychologist from Delhi they made me talk to on video call but I don't know her name or the date. I only talked to her once.

9. On 27th June, my father made me talk to a counselor. His name was Vishal and Kanika consulted him regarding me. I said I need to speak in private. I told him everything about the matter. He just said "these things won't fix in a day" and didn't talk to me further. He asked me to make him talk to my father. My father lied to him that I beat him up and pushed him and other things.

On 17th July, Ambika Agnihotri (26 y/o), a psychologist and therapist from Chandigarh, counseled me. She claimed to be representing the Health and Family Welfare Ministry, but I have payment receipts showing my mother sent money to her from her Axis bank account. This suggests Ms. Agnihotri was either taking bribes from my parents or lying about her affiliation to manipulate me. She promised confidentiality but was in contact with my abuser behind my back. Like other mental health professionals, she asked me to accept and endure the abuse and did not help me report my father's crimes. She also refused to transfer my case so I couldn't get legal help.

On 23 September 2024 , a letter was issued by Priya Seth, Undersecretary of the Medical and Health Department of UP to IMHH, Agra. IMHH, Agra issued a letter to me on 25 September for my institutionalization in the family ward of the institute under the custody of my family/police for detailed examination of my mental condition. Dr. Chanchal Chandra from IMHH was incharge of my case. Neither Ms. Seth nor Dr. Chandra contacted me to know the details before issuing this letter. They did not give me the chance to tell them that this was all a lie and that I was the victim and was locked up for 7 months. Dr. Chandra assisted my father to spread lies about me, writing false reports and declaring me legally insane. She sent the letter stating that I need to be institutionalized under the custody of the police. Dr. Chanchal Chandra has refused to communicate further and has not provided the letter given to her from the undersecretary. She is actively helping my abuser to remain free.
