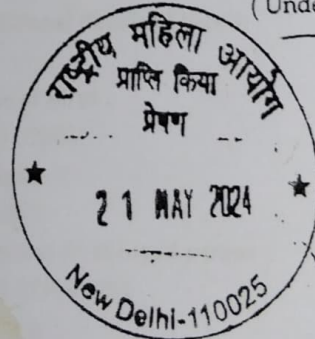

Brief gist of the Complaint

threatened me with violence and forced marriage/rape. On my 21st birthday on 26 January 2024 he sent me a terrifying email suggesting he was planning to kill me or himself. I ran from my house in Ghaziabad to Kerala hoping to escape him.

My father was kept well informed by my teacher of my safety and that I had left home, though not my exact location. Nevertheless he declared me a missing person and claimed I was kidnapped, tracked me down and kidnapped me with the assistance of Kochi police.

I tried many times to escape as he and my uncle tried to gag me, threatening to beat me to death and drug me, but police in New Delhi, Ghaziabad and Firozabad all treated my complaint with contempt. In Ghaziabad, my parents promised police that I would live with my brother and they would not kidnap me, nevertheless I was taken to their house and I have been held hostage there ever since 10 February 2024.

I have not left the house in over 2 months. I had my telephone, laptops and other possessions taken away so that I couldn't call for help. I was frequently assaulted, tortured and forced to sign fake contracts giving up my rights. I was refused food and water and at times my hands and feet were tied with rope. I was often assaulted by 5 men who work for my father who would crush me and suffocate me and at one time my father stripped my clothes in front of them and injected me with a syringe of drugs, telling me I would be unconscious for three days.

Despite repeatedly begging police not to let him take me, every officer I have spoken to has insisted I don't have a right to leave if my father doesn't want me to, even though it's not my home and I haven't lived there for years. I have demanded legal representation,

insisted I need a protection order and attempted to file an FIR but these things are always refused.

My father is mentall ill and talks frequently about shooting us all or killing himself and he has an unlicensed gun and I fear he will use it.

I am not permitted communication with the outside world, access to the internet or a phone, and I have no privacy with him forcing his way into the bathroom or my bedroom. He regularly suggests that he fill "give me" to some unpleasant man who will rape me
