<b>* Description of Information Sought</b>	<p>I am filing this RTI application under the Right to Information Act, 2005 to seek details regarding the unauthorized disclosure of my personal banking information by HDFC Bank to the Cybercrime Department, Firozabad, allegedly initiated by Mr. Ashish Jain. I had opened a savings account with HDFC Bank in Assam. Despite a non-interference order issued by the Magistrate of Firozabad against Mr. Ashish Jain, HDFC Bank disclosed my confidential account details, including transaction history, location, and phone number to the Cybercrime Department, Firozabad, under reference number CR-OB-1160/2024/CyberCrime/Ashish Jain, as communicated to me by Mr. Asif Mehboob, HDFC Branch Manager, on November 14, 2024. No justification or court order has been provided to me by either HDFC Bank or the Cybercrime Department. As per Section 91 of the CrPC, such disclosures must be backed by a judicial order. Information Sought: 1. Certified copy of the order under which the Cybercrime Department, Firozabad, sought or obtained my banking and phone/location information from HDFC Bank, including reference CR-OB-1160/2024/CyberCrime/Ashish Jain and all annexures. 2. Certified copy of any court order authorizing such disclosure. If no such order exists, kindly state: "No court order was sent." 3. Justification and legal basis for the disclosure of my personal information by the Cybercrime Department and Mr. Ashish Jain. 4. FIR/GD/DD number, date, police unit, name and designation of Investigating Officer, and dates of any letters/notices sent to HDFC Bank, along with HDFC's responses. 5. Details of any onward sharing of my data with third parties (including Mr. Ashish Jain), including legal basis and dates. 6. Whether the magistrate's non-interference order regarding Mr. Ashish Jain was on record and considered before initiating any action. 7. Copies of any complaints, FIRs, or information on record in the Cybercrime Department of Firozabad regarding Surbhi Jain and Ashish Jain. I request that all information be</p>
